

From The President's Desk

Study of Society's 1960s Activities Can Help Guide Today's Decisions



In the May and June President's report, I'll be revisiting the activities and plans of the Society in its earliest years—that is, from its founding in 1961 through the 1960s. The Society's newsletternamed Historico shortly after the founding—has proved a fruitful research source.

In the February 2011 issue of *Historico*, I cited trends in membership and membership drives in the early years, noting significant growth in the first decade: from 315 in 1962 to a high of 560 in 1969. In the March *Historico*, I noted that while the constitution written by the founders established an education committee, little was done during the decade to work with schools in the teaching and learning of county and Springfield history except for a project involving high school students recording burials in cemeteries.

However, the Society did some things in the 1960s that might well be beneficial to consider as we move forward. The study of our history can help us make good decisions today.

The 1961 Constitution

Following the Society's organizational meeting on July 12, 1961, the members drew up a constitution, much of which remains unchanged to this day. One change that was adopted addressed the number of terms a president could have without a break. The original constitution allowed three successive one-year terms, although none of the presidents in the 1960s served more than a single term. This provision was amended by 1970 to permit only one term. Recent changes allow unlimited one year terms.

Among the committees authorized by the constitution-makers was a library committee. This committee was to be responsible for collecting and cataloging manuscripts, newspapers and a great variety of other printed material. Although there were discussions about acquiring space to house any such historical resources acquired by the Society and its members, nothing materialized until the opening of the new Springfield Lincoln Library in 1976 and the establishment of the Sangamon Valley Room. Proposals to acquire and display museum materials, whether in a building belonging to the Society or in cooperation with others, were never pursued.

Research and Publications Underway

Although it was not until the 1970s that the Society had a formal and extensive research and publication program with the establishment of the Bicentennial Series, the Society did intend from the beginning to sponsor research and publications. Among the first books were two written by Floyd Barringer, Society president for 1963-64, that were printed privately and donated to the Society. They are *A Walk through Oak Ridge Cemetery* (1967), the first of the Society's many associations with this cemetery; and *Tour of Historic Springfield* (1971). The latter describes 88 structures, most which are houses, and reflects the strong interest in the identification and preservation of historic and architecturally interesting structures in the early days of the Society. In fact, historic preservation was the basis for the founding of the Society. Its role as an advocate for preservation of buildings will be a focus of my June article.

Relations with Other Organizations

As the early leaders thought about what their new Society should be doing, they gathered information about the work of historical societies in other counties. Not only did the SCHS newsletter contain news of these other societies, but from time to time, the Society conducted tours to neighboring counties and invited representatives of historical groups to speak at meetings. Early on, the newsletter instituted the practice of calling attention to activities of related groups—notably, the Abraham Lincoln Association, the state agency for historic preservation, the Illinois State Historical Society, and the Illinois State Museum, where it held many of its meetings in the late 1960s.

Tours Within and Beyond the County

Tours of historic sites throughout the county were an early feature of Society activity. An eight-page detailed description accompanied the 1964 tour to the western parts of the county. Among the more wide-ranging tours were the 1965 and 1969 trips that followed the path of the July, 1861 march of the 21st Illinois Volunteer Infantry troops led by Ulysses S. Grant from Springfield to Naples on the Mississippi River. Tour participants had a meticulously prepared six-page guide of interesting places along the route.

Some Speakers and Topics

Although touring was much more a part of Society activity in the first decade than in recent years, some of the early activities centered around speakers on a variety of topics, much like today, although the place of meetings were often historic and local government buildings. Programs featured speakers on Stephen A. Douglas, David Davis, Springfield newspapers of a hundred years ago, early taverns and inns of Illinois including Springfield's Globe Tavern, the origin and early history of Sangamon County, and the Long Nine. Speakers included academic historians, state and national public history officials, and General U.S. Grant III.

Plans are underway to have available to those attending the Annual Meeting at the Governor' Mansion on June 21 a paper providing an overview of the activities of the founding decade year by year. It will help our members to see how our Society has changed and how it has stayed the same.

Living Memorial to Lincoln

The idea for the garden came from Springfield native and Springfield Civic Garden Club member Harriet Knudson, who in 1936 envisioned a unique living memorial to Abraham Lincoln: a garden composed only of plants native to the three states in which Lincoln had lived: Kentucky, Indiana, and Illinois. Knudson convinced the city of Springfield to donate land along the shore of the newly created Lake Springfield, rallied the Garden Clubs of Illinois to sponsor the curred on November 14, 1936, when project and secured Jensen's services.

special projects with a focus on program development, according to President David Scott. Such programs identified during a strategic planning process (including a July retreat of board members) would include:

- Provide teachers throughout the county with resources so that students can learn more about the history of Sangamon County.
- Enable the Society to expand its programming with expert speakers, special events and meetings at history-rich locations.
- Assist local history organizations throughout Sangamon County.
- Supporting activities to attract young families.

The board could also use the funds for special projects that enhance member services.

"The fund-raising committee hopes that if you have not already taken the opportunity to contribute to the Founder's Fund, you will do so soon. Your donation will really make a difference as we look toward the Society growing its outreach, enhancing its unique role, and giving meaning to where we find ourselves," according to Scott. "Illinois Answers the Call: The Boys in Blue" exhibit at the Presi-

dential library is a must see as we kick off the 150th anniversary of the Civil War. The exhibit showcases the incredible collection of original prints, lithographs, tintypes, cabinet cards and cartes-devisite and the like that have been preserved by the Presidential library. They combine with stories illustrated by letters, sheet music, diaries and sketches created by the soldiers themselves bring home both the heartache and the triumphs of the era. The exhibit will be open from 9 a.m. to 5 p.m. daily and weekends through the summer. In September the exhibit will remain open during



the week on the same schedule until the end of the year....The Illinois State Historical Society's May-June of *Illinois Heritage* will focus on Prairie State museums and feature articles by some of Illinois' top museum professionals.
